Government of the Khyber Pakhtunkhwa intends to undertake "Detail Design & Construction of 6.95MW BARANDOO Hydropower project District Torghar" in public sector through Pakhtunkhwa Energy Development Organization (PEDO). In this regards PEDO intends to shortlist well reputed consulting firms to review and update of exiting feasibility study and PC-I (if required),conduct detail social survey & power demand study, preparation of detailed engineering Design, Preparation of Bidding Documents, Preparation of Technical Specification for procurement and construction, Evaluation of Bids and Award of contract, Review and approval of Design drawings/Technical data, Construction Supervision, Testing & Commissioning of 6.95 MW Barandoo Hydropower project in District Torghar.

The interested firms should meet the following minimum requirements and must attach the relevant documents in support of their applications for pre-qualification for the said project, without which the application of the firm will not be considered.

- 1. The firm(s) must be registered with Pakistan Engineering Council (PEC)
- 2. The firm(s) must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and shall have active status.
- 3. The firm(s) must be registered with Income Tax Department / NTN Sales Tax Number & with Active Taxpayer status.
- If firms wishes to submit their application as a Joint Venture (JV), they must submit JV agreement as per PEC format on stamp paper. In case of foreign firm in a JV, it must have valid registration on Form PEC-4C as per PEC Bye-laws.
- 5. A certificate / affidavit that the firm is not blacklisted by any public sector organization and has not been or involved in litigation during the last ten (10) years with any public sector organization.

Pre-qualification documents can be obtained from the office of undersigned on a written request and upon payment of Rs. 1000/- in form of CDR in favor of GM (Hydel) PEDO during office working hours from the date of publication of this EOI in Newspapers and PEDO, KPPRA websites up to one day before the closing date.

The interested firms must submit proposals (**One Original and Two Copies**) in sealed Envelope at the given address before **1400 hours** on **13 July, 2020**, and shall be opened on the same day at **1430 hours**. Proposals received after this date and time shall not be entertained. Incomplete/Conditional/Ambiguous applications shall not be considered.

PEDO reserves the right to cancel the process at any stage as per KPPRA rules.
