Notice for Pre-Qualification of Contractors/firms

- 1. The Pakhtunkhwa Energy Development organization (PEDO) hereinafter the Employer intends to Re-Invite Bids to Pre-Qualify the constructors/contractors/firms for works under the Project "Access to Clean Energy Programme-Solarisation of 8000 Schools & 187 BHUs in KPK".
- 2. The Pre-Qualification is open to Constructors/Joint Ventures of Constructors who are registered with PEC in Category (C2 E11 (Solar)) for construction and operation of Engineering Works, described in para 1 mentioned above. Applications may be submitted for pre-qualification for the above works.
- 3. Appropriate category PEC Registered contractors may obtain the Pre-Qualification Documents (PQDs) from the office of undersigned or may request to send the same through Email at: tahir.naeem@pedo.pk and saeed.khan@pedo.pk.
- 4. The firms must be registered with relevant tax authorities.
- 5. The request must clearly state "Request for Pre-Qualification Documents for "Access to Clean Energy-Solarisation of 8000 Schools & 187 BHUs in KPK". The documents are available for a nonrefundable fee of Rs 2000/- against CDR in favor of "Solarisation of Schools & BHUs". The documents if requested by mail will be promptly dispatched by registered mail/courier for which cost of mail i.e. Rs 500/- will be borne by the applicant, however, under no circumstances the Employer will be responsible for late delivery or loss of the documents so mailed.
- 6. A minimum requirements for pre-qualification will be to have successfully completed at least 01 X PV Solar Project in last 05 years for value of not less than 5 million Rs.
- 7. Applications for Pre-Qualification must be delivered in sealed envelope by hand or through registered mail/courier to undersigned not later than 18th October 2018,1200 hrs which will be opened on the same day in presence of the bidders at 1230 hrs in Committee Room of PEDO.
- 8. The envelop shall clearly marked "Application for Pre-Qualification for the Project "Access to Clean Energy Programme-Solarisation of 8000 Schools & 187 BHUs in KPK".
- 9. The Employer will not accept late applications.
- 10. Applicants will be informed in due course, of the result of the evaluation of applicants. Only the firms of constructors & JV pre-qualified under this process will be invited to bid.
- 11. Earlier Advertisement on the subject published in widely circulated Newspapers as **INF(P)6402** dated 09 Nov 2017 stands cancelled and withdrawn abinitio.
