EXPRESSION OF INTEREST (EOI) FOR SHORTLISTING OF CONSULTING FIRMS REGARDING CONSULTANCY SERVICES FOR TRANSMISSION INTERCONNECTION / LOAD FLOW STUDIES, SURVEY, ENGINEERING DESIGN, BOQ, PREPARATION OF TENDER DOCUMENTS AND CONSTRUCTION SUPERVISION OF 132 KV TRANSMISSION LINE FOR THE UNDER CONSTRUCTION 69 MW LAWI HPP, DROSH, DISTRICT CHITRAL.

Government of Khyber Pakhtunkhwa has planned to evacuate Power from the under construction **69 MW Lawi Hydropower Project** situated on Shishi River (a left Tributary of Chitral River) at Drosh, District Chitral. The implementation of this project is to develop the power potential available in Khyber Pakhtunkhwa on sustainable basis and to provide cheaper, renewable and environment friendly energy to the National Grid system.

For this purpose, PEDO intends to hire well reputed Consultants to carryout transmission interconnection/load flow studies, survey, engineering design, BOQ, preparation of tender documents and construction supervision of 132 kV Transmission Line for the under construction 69 MW Lawi HPP as per KPPRA rules 2014.

1. Pre-requisite for Short Listing

The interested reputed firms/JVs should meet the following minimum requirements & must attach the documentary proof with their applications for prequalification / short-listing for the said project else the application of the firm(s) will not be considered.

Sr. No.	Description
1	Certificate of Registration with Pakistan Engineering Council (PEC), If in JV there is any Foreign Firm, it should be registered as a Joint Venture with the PEC as required under respective PEC Bye-Laws.
2	Copy of Registration with Khyber Pakhtunkhwa Revenue Authority (KPRA) for the purpose of Sales Tax on "Services".
3	Copy of Registration with Income Tax Department / NTN / Sales Tax Number with active status.
4	Consultancy services provided for at least five (05) similar projects completed during last ten (10) years.
a)	Cost of services, as lead firm, not less than Rupees 20 Million for individual project.
b)	Completion Certificates from the employer clearly stating the services rendered.
5	A certificate / affidavit that the firm is not blacklisted by any public sector organization and has not been or involved in litigation during the last ten (10) years with any public sector organization in & outside Pakistan.

2. Other Terms & Conditions

- All the documents must be provided in the above stated sequence.
- The Consultant will be selected under the Selection Method Quality and Cost Based (QCBS) and procedures, in accordance with the Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) Rules.
- Pre-Qualification Documents (PQD) can be obtained upon the written request from the following office and must reach the office of undersigned on or before **1400 hours on 07-08-2019** which shall be opened on same the same day. No application shall be entertained after last date.
- Incomplete/Conditional/Ambiguous applications shall not be considered.
- Interested Firms may obtain any clarifications / information from the office of the undersigned during office hours.
- Request for Proposal (RFP) shall only be issued to the shortlisted consultants.
- PEDO reserves the right to cancel the process at any stage as per KPPRA rules.
